Council still hampered by rules on decorum

HOLYOKE - Since most recent "class" of the City Council took office in January 2024, there has been much fighting and bickering among the various council-

There has been constant division on various issues, and controversies ranging from choosing Tessa Murphy-Romboletti as the council president, to arguing over simple procedural aspects of meetings.

Eventually, the council would pass a rule for its body concerning proper decorum amongst the legislative body of the city.

But still, fighting persist, even to a point where a council meeting was abruptly ended after only two items were taken up.

Now, the Charter and Rules Committee, a sub-committee of the council, has been saddled with several orders proposing rule changes as well as querying how issues among councilors deal with.

Among the orders, Councilors Kevin Jourdain and Ward 5 Councilor Linda Vacon have proposed an order to amend their rule 6E, adding "that no member of the City Council shall make references to or about another member but in respect-

More volunteers needed to adopt road islands

HOLYOKE - There have been several initiatives on the part of Mayor Joshua Garcia's office imposed to eliminate dirty streets and other forms of blights throughout the city.

Now, the city is in need of help from residents to participate in the "Adopt-An-Island" program.

According to an announcement from the mayor's office made on Monday afternoon, the program has actually existed for decades through previous mayors.

The announcement states there are 25 people returning to the program, but more people are needed to the various median islands in the city clean, free of overgrowth and trash and debris.

The program welcomes residents and local businesses to voluntarily take over empty lots or "islands" in high traffic areas of the city and beautify them by planting flowers, cleaning, and doing landscape work on them.

The mayor's office needs new volunteers to take on an island so we can continue this long-standing tradition and keep our city beautiful. If you are interested, contact Nilka Ortiz by email (ortizn@holyoke. org) or phone (413-561-1600). The mayor's office

needs to confirm participants by April 28.

The program has three rules for participants to fol-1. The city supplies

the standard sign for the sponsor, putting your name or business on display. The city also supplies the wood mulch which is expected to arrive around late April.

2. Sponsors' responsibilities are to provide live plant materials (no artificial flowers), "TLC" - weeding, deadheading, fertilizer, and watering. Spring and fall clean-up.

3. Participants with shrubs and ornamental grasses maximum allowed height is 36".

The mayor's office established the "Flex Squad" in 2022. The Flex Squad is made up of a group of city officials from multiple departments whose purpose is to upholds ordinances prohibiting litter, illegal dumping, graffiti, and other noncompliance issues that exacerbate blight.

The squad is coming up on three years of effective enforcement in the

The Squad is made up of city personnel drawn from the Board of Health, Fire Department, Police Department, and Department of Public Works. The size of the Squad varies, but the usual number of participants is

'Prison Reimagined' comes to Wistariahurst

Wistariahurst welcomes an exhibit of artwork and writing by incarcerated artists critiquing the US Justice System. Prison Reimagined features a series of portraits of U.S. presidents and writing pieces that touch on people's experiences within the prison sys-

The project was organized by Curator and Artistic Director, Cadell "Monty" Kivett from inside a correctional facility in North Carolina. About the project's inception, Cadell states, "...I had an improbable idea: Let's have incarcerated artists draw portraits of our presidents, then invite those subjects to see what we had drawn. This, I knew, if staged in proper context would make for powerful commentary on mass incarceration and criminal punishment in America." Since the project's inception in 2021, Prison Reimagined has grown to an exhibition featuring 23 written and 23 visual works. As the project expanded, Project Manager Janie Ritter and Outreach Coordinator Haley Bryant joined the team, helping push it forward.

The exhibition has traveled to several locations, and Wistariahurst is proud to be the next venue to showcase Prison Reimagined. The exhibit will be on view in Wistariahurst's Great Hall, expanding the area of the museum where art installations are shown, and serving as the first installation visitors will see when they enter. An opening reception will be held Tuesday, April 15 from 4:30 to 6:30 p.m. The opening reception is free and open to the public, and online registration is encouraged. This is the first time McDermott has presented her research to a Holyoke audience.

Holyoke Community College enrolling students for free clean energy jobs training program

HOLYOKE – Holyoke Community College is now enrolling students for a free, four-week program to train workers for jobs in the clean energy sector.

The Green Construction, Electricity and Clean Energy Systems program runs from July 7 through August 1, Mondays through Fridays, 8 a.m. to 12:30 p.m. Classes meet both at Dean Technical High School and at Holyoke Community College.

During 80 hours of hands-on training, students will earn their OSHA 10 safety credentials while learning the basics of green construction, hand and power tool use, and electrical concepts and circuitry, and learning how these skills are applied in solar photovoltaic installation and electrical vehicle charging sta-


Students who complete the program will be eligible for work in construction, can apply for a paid electrician apprenticeship program, or enroll in further training as a clean energy technician.

The program also covers energy efficient materials and design, measurements and diagrams, basic framing, wall installation and maintenance, foundation construction and pouring, workplace safety, and job readiness.


It is funded through a two-year, \$832,000 state grant HCC received in 2024 for climate-related workforce training initiatives. HCC's partners in the grant include the Massachusetts Clean Energy Center, Springfield Works, Dean Technical High School, and the Coalition for an Equitable Economy,

To be eligible, students must be at least 18, authorized to work in the United States, have a high school diploma or equivalency, be able to start work after the training, and pass a background check.

River Valley Counseling Center receives generous donation

lthough the temperatures did not cooperate this past week, I have to say that spring vibes are all around me.

I saw my first blooming crocus, and even some early daffodils. The phoebe bird that makes a nest above our porch door is back, and hanging around, much to my husband's dismay!

My pepper plants are almost in need of transplanting from their seed pack, and the tomato seeds I planted last weekend sprouted in under a week. It is all so exciting! I don't think that I will ever not be amazed at the miracle of it all.

The other day I was going though my seed stash and I found two year old seeds of Loofah Gourd, Mini Popcorn, Mouse Melon and a variety of "climbing" Zucchini all of which I never planted. These purchases were "impulse buys" I guess you'd call it. I bought them but when it came time to actually plant them, I decided that my garden square footage was too precious to waste on frivolity.

But here we are and my frugal nature shines through once more. Since I bought them I might as well try and plant them; maybe one will end up being a new favorite.

minate? Partaking in germination testing gave me chance get my hands in the soil, (albeit indoors) and the outcome will help me determine how much I should "over-plant" or if that will even be necessary.

Wasting a few seeds now will save time later on.

First up, the Loofah Gourd. I planted four seeds as a trial and three popped up! That means I will be adding this to my garden come springtime.

Grow it like you would any other gourd or squash. It loves fertile soil, heat and a strong support.

When loofahs were first popular, I was a young adult and still living at home. Growing them was a project for my parents and I.

Before the first frost we harvested the fat, wrinkly looking cucumbers and allowed them to dry before peeling off the rind. What was left was fibrous matter, looking already very much like a scrubby sponge. It was a fun experiment then and it will be reminiscent to repeat it.

Next comes the Mini Colored Popcorn. This was the first to sprout in my ger-

Another fun thing to try, just to say I did it.

If you are growing sweet corn in your garden be sure to time these apart from one another, so that cross

sweet corn. I was really hoping that the climbing zucchini would sprout in my test pack. It took a bit, but they finally did and therefore they will be added to my garden this spring.

This variety, known as "Incredible Escalator" has a vertical habit. Funny enough, there are all sorts of videos online about training zukes to grow upright, but this variety seems particularly suited to upward mobility.

Zucchini are not true "twining" plants, however, so they will need to be tied to a strong trellis or stake to maintain their vertical nature. Because the plant is off the ground, there appears to be improved disease

resistance, too.

Stay tuned as to whether this zucchini lives up to the hype in terms of productivity and increased vigor.

Last on my list is Mouse Melon. I saw these for the very first time at the Hardwick Fair in 2022, hence my purchase. Also known as Mexican Sour Gherkin, these fruits grow to about the size of a grape, but tase somewhere between a cucumber and a watermelon, growing more sour as they mature.

The seeds were tiny, not what I expected at all and only half of what I planted came up, so I will definitely be sowing double the normal rate. The vine grows long upwards of 10 feet, so be sure to trellis to make the best use of space.

I know little more than you do about this one, but I can't wait to try it out. Will it remain a curiosity or will Mouse Melon become a regular? Will any of these? We'll have to wait to find out!

BBB advises to watch out for scams related to the SAT and ACT tests

For parents of high school students, SAT and ACT scores are a huge deal. With college admissions and scholarships on the line, paying for tutors and test prep materials may be worth the price. But watch out for con artists eager to take advantage of this. Scammers with access to kids' names and school information – are tricking parents into paying for bogus SAT and ACT prep materials.

How the scam works

You get an unsolicited call from a person claiming to be from the College Board, the company responsible for the PSAT, SAT, and AP tests, or another educational organization. The caller claims to be confirming your address, so they can send test prep materials, such as books, CDs, or videos, that your child requested at school.

It seems so believable! Several people reported to BBB Scam Tracker that the caller even had their child's name, phone number, address, school information, and/or the date and location of their child's scheduled test.

Of course, there's a catch. The caller needs you to pay a deposit, sometimes several hundred dollars, for the materials. They claim it will be refunded when the materials are returned

after a set number of days. Unfortunately, if you provide your address and credit card details, the materials will never arrive, and your deposit will never be refunded. Scammers now have your credit card number and other personal information.

One person shared this experience on BBB Scam Tracker, "A woman called, saying that she was from the SAT/ACT College Board. She asked to speak to the parent/ guardian of my daughter, and used her name. She said my daughter had checked the box at her registration, to receive study materials to be sent to her. The materials included access to an online tutor, papers, and two usb drives. The drives would need to be returned within 30 days or we would be charged for them. She was so smooth, she obviously had my number and acted as though she had my address and email already. When I asked, she gave easy instructions for returning the drives. Then she needed financial information to hold the \$250, in case we didn't return the drives on time. This is where I balked, more at the price than thinking it was a scam. Once I told her that we didn't need any of the items that bad, she ended the conversation fairly quickly. It wasn't until after I hung up that I realized she didn't even



quote the correct date for an SAT exam and my daughter doesn't remember checking any box for materials. It was then that I decided to look online to see if this was a scam. (Note: I was very distracted when I took this call and she sounded so legitimate, I nearly got scammed. Be wise whenever anyone asks for money!)"

In another BBB Scam Tracker report, a consumer reported, "He called saying he was college prep for SAT and ACT. He said everything was free of charge and I just needed to put a card down so they have one in the books but when I gave her my card, it declined because I didn't have enough cash on there, so he did not take any money due to insufficient funds, but I am

just reporting the scam."

In a different BBB Scam Tracker report, a consumer shared, "Caller, Carson, stated my son had requested SAT prep materials through College Board student services. He had my address, my son's name, date and location of the SAT test my son is scheduled to take. Caller stated they needed parental permission prior to sending documents and that I needed to give him a credit card number for collateral. "We would be sent the college SAT prep materials; the materials would be free of charge for 30 days and we would need to return the materials in the envelope provided and my card wouldn't be charged. The caller stated they send email reminders prior to the shipping confirmation once the material package is mailed out. My card was charged \$249.95 instantly."

Another consumer shared on BBB Scam Tracker, "I received a call from Brad [redacted] with College Prep Tutors. Stated that my daughter (knew her name) had requested ACT and SAT study prep materials. He said that they would be sent out via USPS and were free if returned within 30 days, but needed to charge my card to initiate the process, and that it would be refunded upon return of the USB materials. He sounded very legitimate and provided a confirmation number. I should have looked further before committing as this appears to be a scam." This consumer reported losing \$250.

How to avoid

test prep scams • Always be wary of unsolicited callers. If someone calls out of the blue asking for payment, always research their organization before you share personal information or agree to receive services or products. Look up the business they claim to represent at BBB. org. Search the name along with the words "scam" or "complaint" to find out if others had negative experiences.

return deadline and will send Check BBB Scam Tracker to see if anyone else has filed a report about the company.

· Double check with your child. If scammers say they are calling because of a service your child requested, tell them you need to check with your child first and hang up. Make sure their claims are legitimate before you call back or accept a return call. Don't send any money or make a payment if there is any doubt about the call. The same is true for emergency

• Understand the College Board's practices. The College Board will never ask you for bank or credit card information over the phone or via email. If a caller suggests otherwise, hang up. Learn more about the College Board's policies.

• Don't give your financial information to strangers. Never agree to pay a stranger for a purchase you did not initiate, with any form of payment. Do not provide details about your credit card, debit card, bank account number, prepaid cards, or digital wallet, such as Cash App or Venmo, and do not wire money. While some forms of payment, such as credit cards, may offer more protections and a chance for a refund, it is still dangerous to share your private financial information with an unfamiliar person.

ful terms whether inside or outside the City Council Chambers including on social media. That the City Council also taken into consideration this time how the City's social media policy should help guide our final

The new rules passed by the council already bar councilors from making disparaging comments about other councilors both on and off the council floor.

There are questions over the ability to suppress free speech, but the order passed.

Another order being considered for recommendation with Charter and Rules comes from Patti Devine.

She asked the law department to issue and opinion on whether a city councilor can be censured for disrupting a meeting or sub-committee meeting. She asked the law department to check other communities with city councilors to see how the procedure to censure a councilor might work.

Finally, she asked the law department to issue an opinion on whether or not there can be repercussion for an elected city councilor who may "Use their position to impede any government operation in carrying out their duties.'

Devine also has proposed councilors be limited to just four minutes of speaking during a given debate. Council meetings have been

going excessive periods of time recently, and the council has been looking at various ways to speed up meeting so more can be accom-

Separate of decorum discussions, Vacon has also made an order seeking a charter change eliminating the elected mayor form of government in favor of a city manager appointed by the City Council. Vacon created the order in December 2023, and it has been tabled for more than a year, last tabled on March 3.

The Charter and Rules Committee will next meet on April 16 in a joint meeting with the Ordinance Committee. All the meetings are televised and made available on Holyoke Media.
