He encourages other writers to take a similar approach to their own writing if interested in publishing.

"Write what you know is 'hack' and it is what everyone says, but it is true, your own voice is important," Lefebvre said. "Also, don't try to write to get published, write something that you think is good."

He also advises those interested in writing to ensure that they read books or written works in the genre they want to

"Read 10,000 books in the field that you want to do," Lefebvre said.

When preparing to write his own book Lefebvre read many children's books on a daily basis. He was able to learn more about what worked in the genre by reading up on it.

"I started taking notes and writing things down," Lefebvre

Micgiel discusses new books

HOLYOKE - Author of Project Eagle: The Top-Secret OSS Operation That Sent Polish Spies Behind Enemy Lines in World War II, John Micgiel, came to Holyoke Public Library to give a talk on his book.

At this talk Micgiel provided some of the background information on what caused him to write this book, and talked through the history told within the book itself.

Micgiel is a native to Holyoke and he wanted to ensure that the community could learn about this piece of

"There are a lot of immigrants in Holyoke, not only from Poland and other parts of Central Europe, but from all over the world and a common thread here of people doing something for the common good," Micgiel said.

The story of Micgiel's book portrays a group of

Progress continues on new construction of middle school

HOLYOKE – The City of Holyoke continues to see tremendous progress towards building a new two-story, 107,475-squarefoot middle school for 550 students, which is on track for completion next summer and to open for students in fall 2025.

On Thursday, Sept. 13, Mayor Joshua Garcia and Superintendent Anthony Soto-

along with more than 30 members of the Holyoke City Council, School Committee, School Building Committee, and Holyoke Public Schools stafftoured the construction site to see the progress

achieved so far for the new middle school building.

"This building is the physical manifestation of what can happen when members of our community work together," said Garcia. "It was great to tour the construction

site yesterday with community leaders and school staff to see the progress firsthand."

The new middle school is an important component of Holyoke's efforts to strengthen learning opportunities and reimagine the middle school experience. The new building will replace the poorly designed, energy-inefficient William R. Peck

School.

Recent progress includes: pouring more $t\,h\,a\,n\,-\,1\,,\,3\,0\,0$ yards of concrete floor slabs; Completing structural steel framing and decking; Completing installation of

underground plumbing and electrical systems; and beginning exterior wall framing and roofing systems in some sections of the new building.

Invitation to join Holyoke's Community Advisory Committee

HOLYOKE - In partnership with the Massachusetts Department of Elementary and Secondary Education, the Holyoke School Committee is developing a plan to transition from state receivership back to local control. The School Committee plans to build on the district's accomplishments and listen to stakeholders about their hopes and expectations for the future of Holyoke's Public Schools and what is important to them as the School System transitions back to local control.

"The Holyoke Public School System is at a critical point in its efforts to realize its vision to become a high-performing school system where students reach their full potential, educators inspire, families are partners, and the community thrives," said Holyoke Mayor and School Committee Chair Joshua A. Garcia.

The School Committee, with support from DESE, is in the process of writing the transition plan and is seeking input to help inform the direction of their work through the creation of an Advisory Committee. The Advisory Committee will be led by two co-chairs, ideally one co-chair from the School Committee and another from the community.

The role of the Advisory Committee

is to help shape the process and content of stakeholder engagement and provide input and feedback on elements of the transition

Students participate in pre-apprenticeship, vocational school training

HOLYOKE – Students from Holyoke Public School's Dean Technical High School took part in the Massachusetts Pre-Apprenticeship and Vocational School Training Program from Sept. 9 through Sept. 13, gaining valuable hands-on experience in the highway construction industry to help prepare them for careers after graduation.

Over the course of four days, students from Dean's carpentry, electrical, auto collision, and diesel technology programs engaged in trainings in both classroom and shop settings, gaining valuable knowledge

in key areas of the construction trades. They learned critical skills such as concrete mixing and surveying techniques, while also earning CPR certification.

The program culminated in a field trip to the New England Laborers' Training Academy, where students toured the facility and received hands-on instruction in scaffolding construction. Throughout the program, strict standards were upheld, with an emphasis on punctuality and readiness to work, reflecting the expectations of real-world job sites.

The program was supervised by

Carpentry Instructor Scot Goulding who accompanied the students to the New England Laborers' Training Academy. Goulding is past president of North Atlantic States Regional Council of Carpenters Union Local 336 and has a long-standing relationship with the Pre-Apprenticeship Program.

Joel McAuliffe, director of Career and Technical Education at Dean Tech, emphasized the importance of providing diverse opportunities for students. "We're committed to doing whatever we can to give our students more opportunities by exposing

them to as many career pathways as possible. Programs like this don't just equip students with technical skills; they also teach them the discipline and work ethic that employers demand. It's about giving them every chance to succeed."

This partnership between Dean Technical High School and the Massachusetts Department of Transportation allows students to take the first step toward promising career paths while still in high school, creating direct pathways to apprenticeships and long-term employment in the trades.

HCC celebrates expansion of college food pantry

HOLYOKE - The new Holyoke Community College food pantry is more than four times the size of the old one. More than that, it is now just steps away from the HCC Campus Center and cafe-

"This new location feels so much more like a hub for our students to receive the support they need," said Amanda Sbriscia, HCC vice president of Institutional Advancement. "The shelves are well stocked. It's bright, it's accessible, and it's judgment free, which is so important."

The occasion for her remarks was a Sept. 10 ribbon-cutting celebration marking the relocation and expansion of both the HCC Thrive Center and the food pantry. Prior to the move, the food pantry occupied a small space within the Thrive Center, which was located in a tight, reconfigured classroom on the second floor of the Frost Building.

Now, the Thrive Center and food pantry occupy dedicated, more spacious rooms side by side on the second floor of the Kittredge Center for Business and Workforce Development, which adjoins the Campus Center.

The Thrive Center (formerly called the Thrive Student Resource Center) helps students address nonacademic issues that can interfere with their studies, such as food and housing insecurity, transportation, healthcare, childcare, utilities, and credit. Thrive also manages the food pan-

"When you think about college and what it takes to be successful, there's so many things that can prevent you from learning," said President George Timmons. "So, this is just another opportunity for us to live up to our mission, which is being an institution of academic excellence that helps remove barriers to student success."

Now, inside the Thrive Center, Ben Ostiguy, Thrive coordinator, and Elizabeth Rivera, Thrive's bilingual program assistant, each have their own offices where they can meet privately with students. There's also an additional office for a soon-to-be hired food pantry manager.

Next door, in the food panty itself, black wire shelving units hold nonperishable food as well as school supplies, baby supplies, and personal care items - all free. There is also a freezer for frozen food items and a refrigeration unit for drinks and perishable items.

What I always tell folks is that our first impression is our first intervention, so the first impression we make with students is pretty critical," said Ostiguy. "I think having a fresh space with updated equipment and designs sends the right message to students. It shows that the campus cares, that this is a priority, and that we are prepared to help them in meaningful ways."

Before the ribbon-cutting, Sbriscia thanked the many donors and partners responsible for making the Thrive Center and food pantry successful, including the United Way of Pioneer Valley, the Holyoke Housing Authority, Rachel's Table, the Caring Health Center, PeoplesBank, Stop and Shop, Gary Rome Hyundai, Hyundai America, One Holyoke CDC, Enlace de Familias, and Tech Foundry.

"If you could, for a moment, just think about what it feels like to be hungry," said Sbriscia, who is also executive director of the HCC Foundation, which manages a special fund on behalf of Thrive. "You're irritable, you're tired, you're distracted. No student should have that feeling as they go through their day. This is a space that ensures that they get what they need so they can do what they are here to do, which is to succeed in college and graduate."

Dear Wondering Widow Provided you have not remarried before age 60, you have a choice which benefit to receive - either your deceased husband's benefit as his surviving spouse or your ex-spouse benefit from your ex-husband while he is still living. Taking your survivor benefit from your deceased husband will likely be best because it is based on 100% of his SS amount when he died, whereas your ex-spouse benefit from your living ex-husband is based on 50% of his Full Retirement Age entitlement. To get an ex-spouse benefit from your ex-husband, which you can't get until you are 62, your own SS retirement benefit would need to be less than 50% of your ex's FRA entitlement.

As you know, you will be eligible for survivor widow's benefits from your deceased husband when you are 60, but be aware that by taking your survivor benefit at 60, it will be reduced for early claiming. Rather than 100% of your husband's SS benefit, at age 60 you will get about 71.5%. Your surviving spouse benefit





Guest Column



Brimfield resident emailed that on Wednesday, Aug. 28, "I sat outside in front of the house and saw 35 common nighthawks, a group of 5, 7, 22 and a straggler. The group of 22 flew around overhead for 2-3 minutes, fluttery flight, erratic, back and forth, round and round." He said he has sat out three other nights and not seen a single nighthawk.

The common nighthawk is 10 inches long and is often seen flying at dusk or dawn and sometimes during the day. They have long, thin pointed wings with a conspicuous white bar near the tips of their wings.

Their flight tends to be high over 40 feet with slow, deliberate wingbeats. The male has a white band near the tip of his tail, which the female lacks. They have mottled feathers with white under their chin. Nighthawks scoop up flying insects when in flight. Sometimes they are seen feeding near city lights, which attract insects.

The common nighthawk gives a nasal "peernt" call. The lesser nighthawk is similar to the common, but flies much lower, 10 to 20 feet and has thin, rounded wings with the wing bar nearer the tip than its cousin.

The female common nighthawk lays two olive brown eggs with dark marks in a nest on gravely soil, fields or gravel rooftops. They inhabit forests, plains and urban areas. Lesser nighthawks prefer rivers, lakes and desert scrub.

Warren bird sightings

In Warren there are still great egrets at the pond on New Reed Street and a juvenile osprey was seen Friday, Aug. 30 at the pond on South Street. It was perched in a tree eating a fish.

Cooper's hawk

My daughter had what most likely was a Cooper's hawk in her yard in late August. She heard a knocking on her basement slider. When she looked over her deck, the hawk was on the ground by the slider. She went downstairs to check on him and he flew up to her deck and then went into a tree before flying off.

A blueberry question



y name is Ed and I have a question that I hope you can answer: I have a small part of my back yard where three tomato plants used to grow. This year I bought a blueberry plant which I never have grown before. I planted it in May of this year and as of mid August I still have not had any blueberries yet. The plant actually looks the same as it did in May. I water the plant every day and just wondering why nothing has grown yet. I actually am considering just letting the blueberry plant stay as is through the winter and maybe by early 2025 there might be some blueberries. Any comment is much appreciated. Thanks!"

Thank you for your question, Ed. I am thinking that your blueberry plant might need a bit more time adjusting to its surroundings, and maybe a correction on soil pH.

Read on to learn about that.

Blueberries, more than tomatoes, are picky about pH. They are ericaceous, or "acid-loving," just like rhododendrons and azaleas. In this part of the country our soil tends to be acidic, but blueberries like an even lower pH than most soils have, to the tune of 4.8.

To find out the pH of your soil, have it tested by the University of Massachusetts Cooperative Extension service. If you specify at testing time that you wish to grow blueberries, they will give you advice on how to amend the soil for that crop.

Some amendments used to lower pH include sulfur, peat moss and leaf humus among others.

I would also recommend that you apply mulch around the blueberry bush to a depth of four inches. As you know, mulch will conserve soil moisture as well as continue to add organic matter and nutrients to the soil as it breaks down.

For blueberries the best choice is well rotted sawdust. Grass clippings and straw are also suitable but need to be replaced more quickly than sawdust.

Loon chick rescue

On Aug.22, Loon Preservation Committee received a call from Pawtuckaway Lake. Lake residents had found a loon chick that had beached itself on an island with no parents in sight. The chick had fishing line tangled around its neck, head and bill.

"As they called, the residents were in the process of untangling the chick and they asked us for guidance regarding what to do next. We were thankful that they had noticed and were helping the loon, and were also thankful that they had called us. Sometimes when loons are tangled in fishing line, there are additional injuries from hooks or tackle that are not immediately obvious when looking at the bird externally and we wanted to make sure that was not the case with this loon."

"LPC's Pemigewasset Region Biologist, Jayden Mowery, was able to meet with the rescuers and collect the chick from them. He then brought it to VCA Capital Area Veterinary Emergency and Specialty (CAVES), where he met up with Maria Colby and CAVES veterinary staff to x-ray the loon. We were glad to have taken this extra step to ensure the chick was okay, because the x-ray revealed something that was not easily visible during the external exam: the chick had a fishing hook embedded in the flesh of its mouth. under its tongue."

An x-ray of the chick's head and neck revealed a large fishing hook embedded in the tissue of its mouth, underneath its tongue. It was removed and the chick was returned to the lake where it joined its parents.

reaches maximum at your Full Retirement Age of 67 and will grow to that point, but will be reduced if taken prior to that.

Also, if you are working, Social Security's "earnings test" will apply until you reach your full retirement age, so your plans for working may influence your decision on when to claim your widow's benefit. If you exceed the earnings limit (\$22,320 for 2024; it changes annually), Social Security will take away \$1 in benefits for every \$2 you are over the limit.

They "take away" by withholding future benefits until the penalty is satisfied, which means you would go some number of months without benefits. And, if you substantially exceed the earnings limit you may even be temporarily ineligible for any SS benefits until you earn less or reach your FRA - the earnings test goes away at your FRA.

If you claim your surviving spouse benefits from your deceased husband first, and your ex-husband later dies, you do have the option to switch to the higher

survivor benefit from your ex-husband. In effect, if both husbands are deceased, you have a choice which benefit to take and, obviously, you'd chose the higher of the

None of this, however, happens automatically. To claim your surviving spouse benefit you will need to contact Social Security directly at 1-800-772-1213 or call your local SS office to make an appointment to apply for widow's benefits.

A word of caution: make sure the sawdust is well rotted or it could potentially burn tender stems as well as rob nitrogen from the plant it is intending to help.

Blueberries can self-pollinate, but for the best berry production plant at least two different blueberry varieties within 10 feet of one another. If, for example, the variety you have ripens mid season, purchase another mid season bush, so that the flowers will be blooming and therefore pollinated at the same time.

You will be delighted with larger fruit and more of it!

There would be some crossover with early and later varieties, but with only two plants I'd err on the side of caution and just purchase another of the same season whatever that is. If you don't know, don't worry about it, just plant another bush regardless.

The last thing I'd like to mention is that it usually takes two-three years for blueberries to produce fruit even if all of their needs are being met. It has to do with the maturity of the branches and whether they are pro-

The most productive branches tend to be around three years old. I'm not sure how old your plant was upon installation, but maybe it just needs a little more time.

Well, we covered a lot of material here, but I can sense how badly you'd like to see your bushes bare fruit. By making a few minor changes and providing the one plant you have with a friend you will hopefully see berries in a couple of years at the most. Thanks for the question, Ed!



hopes of bringing an end to the war, even as their own nation was occupied by the Axis powers.

"It became public knowledge that FDR, and Churchill and Stalin, had... signed a deal that 48% of the Polish State was now the Soviet Union," Micgiel said. "It took the air of these men...because they thought that they were all allies and they were fighting for the Poland they knew."

Even with this struggle, the 32 men pushed through and dedicated themselves to continuing this mission.

"They could have easily said thanks, but no thanks, this isn't for me," Micgiel said.

Micgiel was inspired by this story of dedication by these men, and he delighted to have come across their tale in his own research.

He happened to run across documents in the state department records that hinted at this secret mission.

"It was serendipity," Micgiel said.

As he then moved from place to place he kept the information in his files and, eventually, decided to look into it further.

"I returned to the story of what turned out to be Project Eagle and I had no idea, at all, what I was getting into," Micgiel said.

When he looked back into this information, he went to the records on the OSS and found out that they were in a library in Maryland.

So, he went to the archives and had to find what he wanted within the over nine million documents in the OSS archives.


In the end, between when he first found the note that led him to Project Eagle and the research he did after, it took him four decades to find all of the information and put this book together.

He is beyond proud of this book and he is publishing a second book on the topic.

"It has information from families of people who participated in the missions that were flown into Nazi Germany at the end of the second world war," Micgiel said.

Tough second half hurts Holyoke in Week 1


HOLYOKE - Last Thursday night, Holyoke High School football fell to Pittsfield 36-12.

'Our community's investment in our youth is inspiring," said Soto. "The tour inside the building helped us visualize the learning environment our students will soon experience. I cannot wait to see our students learning together in our new school next year."

The \$85.5-million project was officially approved in June 2023 by the City of Holyoke and the Massachusetts School Building Authority. Of the total \$85.5 million costs for demolition and construction, the City of Holyoke is responsible for paying approximately \$27.1 million (32% of the total project cost) and the MSBA will reimburse approximately \$58.4 million. 

With all of these experiences, he was reading a lot of picture books and fell in love with the genre.
